## Tinubu: Long Tortuous Road to Presidency

If ever he had been vilified, there probably has been no time worse than the last one year when he announced his "life long ambition" to be PREZDENT. Of this figure, only 24.9 people voted for 18 candidates with Tinubu polling an "insignificant" 8,794,726 votes.

A friend once responded to a post on Facebook referring to Tinubu as the next Nigerian president. Whose president, he asked. Another respondent answered him saying, president over the 200 million Nigerians that make up the population of the country. Our friend insisted that with the available statistics the verdict of the 25 February 2023 Presidential election was a vote of no confidence. Migration is as ancient as the planet earth. For diverse reasons, human beings and even animals and birds move locally, regionally and internationally. For some, it is for water,

escaping famine, conflicts, discrimination, religion, etc. From a modern economic point of view, it is also about opportunities. It is all economics, a search for opportunities and better life, as in Marian Babangida's pet project for rural women. As long as rural women or men or children don't have better lives, migration to urban or other countries is a given.

Economics also conceptualizes the gains and is the instigator of the decision to move or not to move; in that, as long as the gains outweigh the losses, one will invariably Japa . intentions of modern states' immigration policy. Like the former slavery policy, which was an economic one by Western Europe and America, the modern day depletion of the third world labour force still wears an economic designer outfit

The Third world has assumed the status of a desert and a disaster zone where people flee from. This emanates from a neo-colonial dependent economic structure perpetuated by Western Europe and America. The ultimate result of this exploitative policy is the reflection it has in the minds of third world people; they see themselves in the dark and light only exists in Europe and America, hence they grab every opportunity that lands them there. Unfortunately, the only calculation they make in their decision is, the projected gain in japa. The realities of the situation only dawn once the immigrants have settled in their new western abodes.

A brighter side comes from a few resilient immigrants who eventually break the bars, achieve success and become the signpost and poster boys and girls of the unintended policy. Messrs Joseph, Jacob and Daniel in the Bible were immigrants by slavery and wars of conquest. Yet they became prime ministers in Egypt, Babylon and Persia respectively. We are already having immigrants occupying the highest offices in their new countries. Nigeria will join that league in time, not only changing the narrative, but the whole story.

But the real solution is for Nigeria and other African countries to stand up and seize control of their economies from the dictate of the west. Then they will be like China and India. While China may still need to fire a gun to win America and Britain, India doesn't need any gun: Rishi Sunak and Kamala Harris have done the conquering for India. And Canada could well be next. The world economy can only ignore India at its peril. India's time has arrived, whether Indians migrate or not. When they migrate, they take Canada, US and Britain or anywhere they decide to.

Japa like any venture, requires full information for evaluation and decision making purpose. So anybody considering it should ensure he or she is properly informed.

# Governance in Post-2023 Elections: What Should The President Do?

The impression about the presidential campaign of the 2023 general elections has come and gone. The proliferation of hate has softened. The jingles, dancing steps and catchy regalias have halted. No more gaffes, blunders and slip of tongues, as it were. Certainly, a fresh powerbase is evolving even when the critics have resumed the business of complaints in earnest pace. Those who suffered electoral defeat are already putting together loads of petitions and are on the verge to advance them at the election tribunals, hoping that the sacred judiciary will reverse the INEC declarations.

After days of divisive campaigns, 18 political parties and flagbearers took part in the presidential elections on Saturday 25 February 2023. Again, the inability of the Independent National Electoral Commission (INEC) to transmit electoral results electronically cast a shadow on the polls, but nonetheless, a winner was declared.

Bola Ahmed Tinubu of the ruling All Progressives Congress (APC) polled the highest number of 8.7 million votes to emerge victorious. Atiku Abubakar of the Peoples Democratic Party (PDP) got 6.9million votes, Peter Obi of the Labour Party (LP) scored 6.1 million votes, while Rabiiu Musa Kwankwaso of the New Nigerian Peoples Party (NNPP) came fourth with 1.4 about million votes.

With the conclusion of the election, come 29th of May, 2023, Bola Tinubu should take charge of the mantle of leadership from Muhammadu Buhari as the 16th President and Commander-in-Chief of the armed forces of the Federal Republic of Nigeria. There are high expectations for the next president to hit the ground running in the realization of his campaign promises and policy choices in his 80-page manifesto.

#### **Inherited Overarching Issues**

Since attaining political independence, and particularly after the fourth republic, Nigeria has had to contend with several socio-economic and political challenges. First, the country is largely polarized with the cleavages and centrifugal forces cutting across sectarianism, sectionalism, ethnocentrism, parochialism, and religious chauvinism. The polarization that is pushing the country to the brink is evident in discussions around the existential rotational presidency, the controversial reservations about presidential flag bearers and their creedal affiliations, and the bigoted and toxic ethnocentric perceptions parading the conventional and social medium platforms.

Second, with Nigeria supposedly being a federal republic, the country is governed by a unitary constitutional arrangement in which the federal government wields overarching powers. Shaping its federalism alongside that of the USA, Nigeria is structured as a federation with 36 states with a federal capital territory and 774 Local Government Areas (LGAs). Unlike the United States, however, the central government manages in its entirety, the revenues and

arguably all of the country's resources, especially oil and natural gas. The revenues accrued into the Federation Account are thereafter allocated to states and LGAs on monthly basis by a federal executive body, the Revenue Mobilization, Allocation, and Fiscal Commission (RMAFC). This artificial political arrangement is inimical to the ideals of federalism and continually informs the perennial call for restructuring which affords component units the opportunity to manage their resources, develop at their respective pace and improve healthy rivalry across regions and Nigeria by extension.

Third, the country in the last decade has faced increased security challenges. The brutal and receding Boko Haram terrorist engagements in the North-East are continually being substituted by the combination of killer gunmen, banditry and terrorism in the North-West. The North-Central are left to battle the deadly farmerherder crisis whilst the South-East is enmeshed in secessionist agitations and other associated criminal opportunism. There is an increasing upswing in kidnapping and ritual brigandage in the South-West while the South-South is largely afflicted with oil thievery, piracy and militancy. Fourth, the country is immersed in a struggling economy with slow economic growth and progression. The rigid and faulty implementation of the cashless policy has resulted in a selfinflicted cash crunch that has subjected the entire populace to hardship in going about their

daily routine. The national currency (naira) has been devalued amid a volatile exchange rate, inflation, high and rising unemployment rates, and unprecedented cum unbearable cost of living which successive government seems to have lost traction in the business of managing the national economy and planning.

Fifth is the question of fuel subsidy. A situation where the revenue accrued from the sale of crude oil is returned in exchange for the importation of subsidized refined products. So clearly, the government is doing trade by barter which is not sustainable. This has resulted in public policy controversies since the early eighties. Part of the controversy is a lack of clarity and context from both those who call for its removal and those who are opposed to it. However, there are three core issues at play in the debate over fuel subsidy: its fiscal impact on the overall economy; the political cost of its removal; and the question of where the savings from removing subsidy will go within the government. The fiscal implication of fuel subsidy on the economy in Nigeria is indeed worrisome. Nigeria's subsidy payments clocked an aggregate of N10.4trn in the period of 13 years between 2006 and 2019, according to data published by the Nigerian National Petroleum Company Limited (NNPC Ltd) in April 2022. And in the 30-month period from January 2020 to June 2022, subsidy payments (N3.92trn) equated to the allocation for education and health combined (N3.96tn). Consequently, subsidizing the price of fuel gulps away public finance that could have addressed infrastructural deficit and social services directly affecting the poor, particularly education and health. It increasingly worsens the value of the naira and increases avoidable governmental debts.

Sixth, corruption represents an endemic and

systemic menace in Nigeria's private and public functionaries. With the claim of the current administration to tackle public corruption, a former Accountant General of the Federation has been alleged to have swindled well over 100 billion naira (US\$216,449 million).

#### What Should The New President Do?

The following are some urgent and serious issues awaiting the President-elect's intervention, now and in the early days of his government. Interestingly, he has promised in his acceptance remarks to hit the ground running. He has promised "to listen and to do the difficult things, the big deeds that put us on the path to irreversible and accelerated progress. Hold us firmly to account for our stewardship, but please give us a chance first", he added.

#### Reconciliation and Bridge Building

The hatred and hostility that surrounded the campaigns and electioneering pushed the country to the extreme edge. The people were highly divisive across religious, ethnic and partisan lines. With the conclusion of the elections, one of the most important tasks for the president is to ensure unity and call for calm frayed nerves to pull the nation back from the brink. Bola Tinubu affirmed the need for this when he extended his hands of friendship to his fellow candidates after the release of the electoral results.

"To my fellow candidates, former VP Atiku, former governor Kwankwaso, former governor Obi and all others, I extend the hand of friendship. This was a competitive, high-spirited campaign. You have my utmost respect. "Political competition must now give way to political conciliation and inclusive governance. During the election, you may have been my

opponent but you were never my enemy. In my heart, you are my brothers."

Tinubu sued for peace to reign and tension fading away. "Yes, there are divisions amongst us that should not exist. Many people are uncertain, angry, and hurt; I reach out to every one of you. Let the better aspects of our humanity step forward at this fateful moment. Let us begin to heal and bring calm to our nation." In addition, beyond suing for harmony among other presidential candidates, there is an urgent need for the president-elect to ensure his government is inclusive to accommodate qualified hands across different ethno religious groupings while putting up his cabinet. Furthermore, every policy choice of the new government must be people-spirited, reflecting the differences across the board. This will undoubtedly douse all tension of centrifugal tendencies and create a sense of inclusion for all and sundry. The extent to which the presidentelect is able to tame and reconcile with divisive forces goes a long way in determining his direction in delivering his mandate.

#### Security

The biggest challenge for every successive government in Nigeria is insecurity. With Bola Tinubu not being an exemption, he will be inheriting a highly fractured country of despaired citizenry. The brutal and dastardly engagements of the Boko Haram terrorist group for two

decades in the northeast part of the country are alarming. The acts have blended into other criminal activities like banditry and other organized crimes in other parts of the north which translate to a situation whereby the country with the largest concentration of black people is on life support.

As reported by the Centre for Democracy and Development, not less than 30,000 gunmen split into 80 groups are operating as bandits, agents of fear, tears, and death to an already traumatized populace. On a recurrent basis, gunmen murder, abduct, and maim innocent citizens on our highways and sometimes from the comfort of their homes and offices. Other soft targets of these criminals include but are not

limited to students, academia, clergymen, and even security personnel.

The new administration must be deliberate and decisive to introduce a mechanism beyond the conventional rhetorics to defeat the menace of insecurity and restore the dignity of man.

"The number one focus of any government should be the security of lives and property. The new government must work hard to restore peace and security.

With the conclusion of elections, the new government must be decisive in the massive investment in surveillance and investigative technology and other related infrastructure to address the question of insecurity and not just

employ more hands in the conventional security apparatuses. Nigerians anticipate the return of a time when they can travel far and wide within the country without fear of victimization or threats to their lives.

#### **Revamping the Economy**

If Nigeria is to survive the economic crisis of the moment, there is an urgent need to remove the petrol subsidy, deregulate the exchange rate, downsize the government's payroll, institutionalize credit schemes, and widen the tax net. There is a need to be aware and conscious of the fact that the present financial burden of the government is not sustainable and the next president must be prepared and deliberate to tackle the issues. The president must be responsive to the call for greater state autonomy and be prepared to give federal oversight powers over areas such as education, and management of state resources to component states.

The steps and actions to be taken to revamp the economy will be painful ones and the electorate will not be interested in giving breathing space or listening to excuses, hence the president must be decisive in taking far-reaching decisions and map out ways to cushion its effect on the vulnerable.

#### Fuel, Solid Minerals Development

It is no news that four major refineries in the country have not been working for ages. Experts have opined that one of the major determinants of the continued scarcity and increase in the price of petroleum products is as a result of the nonfunctional state of our refineries. Thankfully, a private refinery owned by Billionaire Aliko Dangote is set to significantly bridge the gap with the government having a share in the

strength of the refinery.

In a way to diversify our economy, the new government must pay attention to gas and solid minerals. The country is blessed with various mineral deposits to the tune of 32 of them, that are either lack exploration or underdeveloped. With the abundance of more gas than oil, what is stopping us from turning them around to wealth creation?

The iron and steel industry deserves special mention. The moribund steel complexes in Aladja, Delta State, and Ajaokuta, Kogi State need to be brought back to life as a matter of urgency or sold off to private sector. The efforts will largely create thousands of jobs and reduce the figures of idle hands away roaming the streets.

#### Restructuring

To restructure is a form of political decentralization and differential economic model necessary, if not sufficient for solving Nigeria's most vexing challenges associated with power and responsibilities distribution. To create an economically viable and politically functional

polity, the new government working in conjunction with the national assembly needs to completely overhaul the political system geared to achieve an enabling environment for component units to thrive. While such changes might, in the short term, trigger upheaval, upset

entrenched power arrangements, and exacerbate existing tensions, in the long term, political restructuring would be beneficial for both the north and the south. Former Nigerian military head of state president, Ibrahim Gbadamosi Babangida stated in 2017, that Nigeria's future is inextricably linked to restructuring its political system. However, political restructuring will only be effective when pursued in a democratic, participatory, and coordinated manner.

#### **Effective Communication**

The President must be habitual in communicating with Nigerians about his journey, shortcomings, and mistakes at intervals. If he accepts the principle, he would be able to set a standard so high that would be non-retractable in four years, and unarguably impossible for the successive president to eradicate.

His government should make reportage to the nation around policy choices and implementation on a continuous basis and not merely occasional announcements. When pursued closely, it would influence every unit of governance and other public parastatals without being asked to do so. This communication schema brings the public to the corridors of the democratic process in between elections and makes true performance a real factor during elections.

This strategy would enable the public to identify patriotic Nigerians with actual leadership potential; people who will evolve as they make a report of their vision, mission, and challenges experienced over time.

#### Harmony and Unity

The President must demonstrate unifying qualities in his administration. Beyond economic

The National Orientation Agencies (NOA) must be rekindled in their mandate of ensuring the populace is fed with the requisite orientation and information required to understand the nation's patriotic spirit.

#### **War Against Grafts**

Corruption must be decisively fought in a micro and macro setting with severe punishment and stigma associated with such vice. Monitoring especially for capital projects should be sorted out at the preplanning stage and continuously monitored and fine-tuned as the execution progresses against set Bench marks.



#### **Architects**

The architect is the leading consultant in the construction (BUILDING SUBSECTOR) team and he brings the Clients dream to visual reality on paper and sometimes in physical models. The architect's roles includes receiving briefings from the client, advising him/her on the practicality, Pros & Cons of his choice of Design as well as submitting chosen design ongraphics and scale Models (optional) to engineers and Quantity surveyors for Engineering Designs and Final Cost estimates.

Upon settlement of the choice of design the architect in conjunction with the client would proceed towards the selection of a preferred contractor (optional) and continuously monitor/ supervise the construction process to ensure adherence to the design or if necessary carry out a review by suggesting alternative choices as expedient on site.

The modern Day Architect of the New Nigeria apart from possessing requisite ARCON certification would be expected to be professionally sound in terms of intellect and morally

The Engineer is engaged to render structural engineering services for the architects designs (Building Projects) or for the design of infrastructural facilities (Civil/ Mechanical/ electrical Projects)

The new Age engineer would be expected to be Educationally Qualified and professionally Certified as Chartered Engineers of COREN/NSE. He's also expected to engage in continuous Professional Development to avail himself of current trends in the industry as while bearing allegiance to the interest of the client at all times without compromise to his professional integrity.

#### The Quantity Surveyor

The Quantity Surveyor is the professional cost economist of the construction Industry. His schedules includes

- (1) Preparing cost estimates for each stage of the construction processes designed by the architect (BUILDING PROJECT) or the engineer (for civil/ Mechanical/ Electrical Projects)
- (2) Monitoring of execution and preparation of program reports periodically to ensure adherence to the programme of works and estimates
- (3) Monitoring of inflationary trends and adjustment of the work plans/ schedule in accordance with such adjustments.
- (4) Preparation of final cost estimate upon completion of works. Irrespective of severe temptation to the contrary, the allegiance of the Quantity surveyor should always be to (a) His professional Integrity (b) His Client and lastly the Contractor/ Subcontractors.

He's equally equally expected to engage in CPD activities to keep himself abreast of current trends in the industry at all times.

#### Builder/contractor/subcontractors

The Builder/Contractor enters into a contractual agreement with the client towards the construction of the project be it Building, Civil, Mechanical, Electrical or a combination of all of these as an integrated works for a set or varied fees and for a stipulated timeline and specifications. The Builder/Contractor/ Subcontractors should be well versed and experienced enough in the particular item of

# Subcontractors should be well versed and experienced enough in the particular item of works he's tendering for

works he's tendering for while also possessing enough Human resources, Equipment, Machines and Tools of the requisite type for the particular project.

Professional Integrity, Competence, Business acumen and proficiency in Methodology of Construction should always be the guiding principle of the Builder/ Contractor/ Subcontractor.

The aim at all times should be Quality Delivery at budgeted cost and stipulated timelines: The Builder should ensure that funds are not diverted from the particular purpose for which it is meant. Safety practices should scrupulously be adhered to and enforced by established safety personnel so that site accidents and incidents are kept to the barest minimum on construction sites. The builder should also engage himself, his Agents and entire organization in CPD activities regularly in order to freshen their

adjudicating on the resolution of cost-based disputes that normally arises on construction projects.

## Financial Vehicles for Quick Economic Turnaround

#### **Money Matters**

Money matters for all development -be it personal, corporate, or in the public economy. The first step is setting up the necessary financial institutions or markets that will actualize the economy's developmental agenda. These institutions, starting with the central bank and other financial markets regulatory bodies, banks, finance companies, insurance and the stock exchange are already in existence, have been reformed several times and are doing averagely well in Nigeria. But the necessary effects translating to economic growth and full employment have not been discernible for over a decade now. Is there a need for reset? What must be done to make the contributions of the financial industry meaningful and beneficial to the components of the Nigerian economy?

The Role of the Banking Industry

The Nigerian banking industry is one of the largest and most developed in Africa. It is composed of several different types of financial institutions, including commercial banks, microfinance banks, development banks, and

merchant banks. The Central Bank of Nigeria (CBN) serves as the regulatory body for the banking industry and is responsible for setting policies and guidelines that ensure stability and growth within the sector.

In recent years, the Nigerian banking has experienced significant growth and



transformation driven by factors such as the adoption of innovative technologies, increasing competition, and the introduction of new financial products and services. The creation of the Nigerian Inter-Bank Settlement Scheme (NIBSS),

that serves as the Nigeria Central Switch, Payment Terminal Service Aggregator and Nigeria Automated Clearing House, coupled with the introduction of the Bank Verification

Number (BVN) has resulted in a step change in financial transacting in Nigeria. This gave Nigeria the lead in instant payment across Africa and today instant payment a.k.a. Alert, is commonly accepted as payment for goods and services. According to data from the Nigeria Stock Exchange (NSE), as of March 2023, the total market capitalization of the financial services sector, which includes banks and other financial institutions, is estimated at 4.03 trillion Nigerian Naira (about 9 billion US dollars). This is comparatively low to South Africa where the 6 listed banks have a capitalization of 58.7 billion USD.

Banks are meant to be a catalyst of development, however, the Nigerian Banking industry continues to be shy in asset creation, especially in the Consumer and SME sectors of the economy. This phenomenon translates to unavailability of credit to these vital sectors thereby impeding wealth and job creation by the SMEs, with a resultant high unemployment rate (37%).

According to a recent McKinsey study:
"In addition, there is scope for the industry to come together to build on this foundation, enabling the next wave of shared services.

Specifically, the sector can leverage payments data—including a Bank Verification Number (BVN) database of 43 million—and other nontraditional sources of data to build new credit algorithms that can unlock lending for SMEs and other under-served segments. Together with the recent Global Standing Instruction policy, this could be the critical enabler for credit growth in Nigeria's deposit-rich and asset-poor banking industry."

The necessity to lend to these under-served segments of the economy is critical for the banks to stimulate economic growth in the country with the combination of the CBN, Ministry of Finance and indeed the Federal and State Governments enacting favourable policies and creating a commensurate enabling environment.

Lastly, the pandemic had a significant impact on the banks which deeply impaired revenues due to defaults and contractions in the economy. Revenues and profitability are not expected to return to pre-pandemic levels till 2024. However, it is an opportunity to reset and change the focus to the lower end of the markets that will stimulate increased economic activities and relevance of the sector.

Making Financial Matters Interesting for Households and Firms Leveraging Technology

The advent of the ubiquitous mobile phone, and especially the smartphone have made Digital payment a reality in Nigeria. The term universally used, "Alert"!, simply represents NIBSS Instant Payment (NIP). The introduction of this type of payment about 12 years ago, has transformed person-to-person and person-to-corporate payments in Nigeria,

popularity can be attributed to ready availability of Smartphone devices, better Telco networks, enlightenment, and access to Banking accounts. Also, the Banks have invested in developing apps that work on Mobile phones enabling access to banking services. They also invested in USSD services that run on both feature and Smartphones.

Today, any Nigerian with a Bank account can make instant payments of up to N500,000 and on request can have this increased to as much as N3m. Cash nevertheless remains King! The combination of Agency banking, Mobile Apps and USSD services as readily offered by almost all Commercial banks, coupled with ease of access to Bank branches and ATMs in the urban communities has enabled a significant increase in the velocity of financial transactions in Nigeria as a whole. The master stroke to all this, is the instant fulfillment that NIBBS enabled and guaranteed which is still not available in most African countries and even several western ones . For example, Zelle is a new service in the USA (launched In 2017), while Nigerians have been "Alert(ing)" for 12+ years.

Monetary and Fiscal Environments
The principal role of monetary policy is financial deepening. An economy that requires trillions of dollars to develop infrastructure and industries but has total banking sector capitalization at \$9 billion is far from achieving a financial deepening goal. The focus of monetary regimes in an economy that works should be financing production and services. This is, as identified

above - lending to SME's and consumers.

The banking sector will have to revisit recapitalization and consolidation issues again. If the thrust of monetary policy is deposit creation for financing businesses, banks' financial bases will have to be enlarged.

The core of banking business is credit financing. It is the money side of demand management. Individuals and businesses need access to long term finance by the banking sector. Mortgages, car loans and other consumer short, medium, and long terms loans are the stimuli that the economy needs to propel it to full employment and prosperity.

The other side of the coin is government spending. Though it is supposed to be contingent on tax revenue, it is always in short supply.

What the Nigerian economy requires now is money, money, and more money. And the emphasis of the monetary authorities should be getting the banking system to supply money in an unrestricted manner; dismissive of inflation. The inflation in Nigeria today is mainly due to supply bottlenecks and not in tandem with theory. An economy in a state of underutilization and underemployment of resources cannot be said to exhibit inflationary trends, as a tradeoff theoretically exists between unemployment and inflation.

Complimentary fiscal policy in demand management will have to involve fashioning appropriate tax regimes. Tax is a big fiscal instrument for generating revenue for financing infrastructures and other projects. In a bid to raise their internally generated revenue profile, and to be less dependent on dwindling oil revenue, states and by extension local governments are indiscriminately using taxation, which is adversely affecting economic growth and development across the nation.

With the minor constitutional amendment that took place recently, the nation is moving toward unbundling or devolution. This must be hastened regarding financial autonomy of the local governments. At that point, there will be a need for the appropriate tax instruments to be used by the various tiers of government in order not to strangulate the economy with tax burdens.

The other side of the coin is government spending. Though it is supposed to be contingent on tax revenue, it is always in short supply. Consequently, government spending is also driven by domestic and foreign borrowing to finance infrastructure. Borrowing must be to finance infrastructure with multiplier effects and not for consumption. The outgoing Buhari administration has maximumly leveraged borrowing to finance development and the incoming Tinubu administration has consistently harped on continuing in that direction to reduce the infrastructural deficits in the economy.

### Live A Full Life With Sickle Cell Disease

What is sickle cell disease (SCD)
Sickle cell anemia (sickle cell disease) is a
disorder of the blood caused by an inherited
abnormal hemoglobin (the oxygen-carrying
protein within the red blood cells). The abnormal
hemoglobin causes distorted (sickled) red blood
cells.

#### Occurrence

SCD is predominantly a blood disease affecting blacks and African Americans

- Approximately 2000 infants are born annually with the disease
- SCD affects approximately 200,000 Americans annually
- 1 in 365 African Americans
- 1 in 13 African Americans have the traits (carrying only 1 of the gene, S)
   (CDC August 2017, Mayo Clinic

#### **Economics of SCD**

10 years ago, medical expenditure for children with SCD averaged \$12,000 yearly for those with Medicaid and \$15,000 yearly for those with commercial insurance. There were also 113,000 hospitalizations costing over \$500,000 paid by Medicare and Medicaid of which 75% of the visits were in adults and each with at least 3 Emergency Room visits per year. Children with SCD miss a minimum of 18 days per school year.

Nowadays total healthcare costs for SCD are in the neighbourhood of \$2billion per year.

#### Causes of SCD

Healthy red blood cells are round, and they move freely through small blood vessels to carry oxygen to all parts of the body. In SCD, the red blood cells become hard and sticky and look like a C-shaped called a "sickle" and they are not able to carry enough oxygen. When they travel through small blood vessels, they get stuck and clog the blood flow.

The sites most often affected by clogging or stacking of sickle cells are found in the lungs, liver, muscle, bone, spleen, eyes, and kidneys and other parts and tissues of the body: this explains why patients complain of a lot of pain in these areas as the symptom of the disease.

Patients also have immunity suppression, which leads to infections by bacteria, and viruses.

Genetic counseling and testing (better before marriage and at pregnancy) can help prevent the likelihood of passing gene to your child

#### Symptoms of SCD include

- Excessive fatigue, irritability from anemia
- · Jaundice (yellowing of eyes and skin), may also include retina damage
- Swelling and pain in hands, and feet, pain in chest, back arms and legs, also damage of hip
- · Frequent infections,
- Pain and problems in the spleen, (Nausea, vomiting, diarrhea)
  - Delayed growth
  - Stroke (20-30% of children stroke, 23% in

Genitalia (priapism, a constant erection, in which severe episodes may lead to impotency)

#### Treatment of Sickle Cell Anemia

Treatment of SCD pain or crisis is in the following manner:

Rehydration

With IV fluids, helps Red blood cells return to normal shape

#### Drugs

- Antibiotics: use to treat underlying infections. In some cases, antibiotic prophylaxis and penicillin.
- Pain medications to treat acute pain
- · Hydroxyurea: helps increase production of red blood cells

**Immunization** 

Pneumococcal and Meningococcal vaccines have drastically reduced the rate of infections in SCD Blood transfusion

Improves oxygen and nutrients needed Supplemental oxygen

By mask makes breathing easier and improves oxygen levels in the blood

Bone marrow transplant

For severe complications and matching donors.

Genetic counseling and testing (better before marriage and at pregnancy) can help prevent the likelihood of passing gene to your child

- Preventing infections is by practicing simple hand washing techniques at every opportunity. Hand sanitizer gels and wipes are also available and affordable
- Immunization and it is important that shots and records are current to cut down on the rate of common infections.
- · Rehydration with fluids at all times is essential.
- Avoid staying in places with low concentration of oxygen, e.g. unpressurized airplanes, or high altitudes.

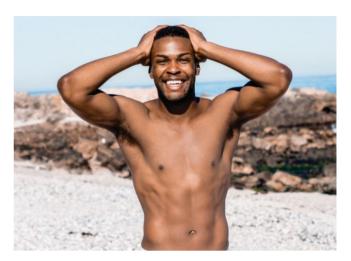
#### Shoes

## A Yearning for The Revival of Nigerian Football

#### Origin

Nigerian club and national team football have a long history. Records indicate that the very first football match was played in 1906, in a competition to win the Beverley Cup, in Calabar. It would take another 39 years for a national team to be formed in 1945. A countrywide and popular club football competition named the War Memorial Challenge Cup was begun in 1942 and over the years transformed, first into the Governor's Cup in 1945, the FA Cup in 1954, and then the Challenge Cup in 1960, upon Nigeria gaining independence from the British empire. The Coca Cola company would go on to sponsor the FA Cup in 1999 and the Federation Cup in 2009.

The earliest football clubs that captured the nation's imagination included Marine, Corinthians, Lagos Railway, Lagos ECN, Warri, Ibadan Lions and Port Harcourt. Also, while clubs such as Kano Pillars and Plateau United have stood the test of time, (albeit changing their names to Raccah Rovers of Kano and the Mighty Jets, of Jos respectively before returning to the original ones. The late 6os and 7os ushered in clubs like Stationery Stores of Lagos, Enugu Rangers International, Alyufsalam Rocks of Ilorin,

IICC Shooting Stars of Ibadan, Bendel Insurance, Sharks of Port Harcourt, Niger Tornadoes, DIC Bees of Kaduna, Spartans of Owerri and numerous others, many going on to become household names.

While the ownership and running of the early clubs were invariably the remit of government institutions initially, such as Marine, Railway and ECN, a dilution later emerged, with some clubs being privately owned. Stationery Stores of Lagos, founded in 1967 by Chief Israel Adebajo

was a pioneering example. Over the next decades, club control would go on to become a mixed bag of private and public funding, with the state governments playing the leading role.

The national team was formed in 1945 and given the name "Red Devils", in 1960 this was changed to "Green Eagles" and re-christened the "Super Eagles" in 1980, a name now stamped in global football's imagination. The management of the national team has always been the responsibility of the Nigerian Football Association (NFA), later to become the Nigeria Football Federation (NFF).

#### The Glorious 70s

As football, both club and national took hold in the public mind, the players became heroes and overnight sensations, their names etched in the hearts of millions of football loving citizens who couldn't get enough of the sensational performances of these gifted individuals. Talent was largely pooled from the secondary schools but the streets were significant too, many youths thereupon finding their way into the club limelight from both sources. Early Nigerian footballing excellence was embodied by the likes of Isaac Akioye, John Dankaro, Teslim "Thunder" Balogun and Etim Henshaw. In 1972, a National Stadium was completed in Surulere, Lagos with a capacity of well over 70,000 spectators, opening the door into the magic of Nigerian football for my generation.

Stationery Stores of Lagos produced stars like Sanni Mohammed and Yakubu Mambo, while Enugu Rangers had Gideon Njoku, Matthias Obianika. Sharks of Port Harcourt, Sunny Oyarekhua and Victor Oduah. Mighty Jets of Jos had the Atuegbu brothers - Andrew and of Senegal, TP Mazembe of Zaire, Zamalek, and National SC of Egypt, Hafia and Horoya of Guinea, ASEC Mimosa of Ivory Coast, Molouda Chalia of Algeria. While the powerful duo ofEnugu Rangers and IICC Shooting Stars of Ibadan took center stage with national league domination and strong forays into continental club championships, the national team, Green Eagles took the bronze at the 1976 African Cup of Nations hosted in Ethiopia, and signaled the arrival of the Nigerian national team as a continental football force.



At home, the talent source was widening as state secondary school football competitions flourished, particularly the flagship Principals' Cup which attracted a large audience of students and shot outstanding players into major reckoning. Nigeria also regularly held the popular National Sports Festival with representatives from all the states energetically rivalling each other for accolades and recognition. The potential of discovering new stars from this competition was a big selling point too .

With memorable matches coming thick and fast, both for the clubs and country, one thing was guaranteed at stadiums across the country.

Football fans packed them to the rafters, arriving

4 or 5 hours before kick-off. Fans thronging the Liberty Stadium in Ibadan clapped, cheered and sang in adoration of the skills of Segun Odegbami, Best Ogedegbe, Moses Otolorin, Folorunsho Gambari, Idowu Otubusin, Samuel Ojebode and Muda Lawal. In Enugu, fans crammed the Enugu Stadium to watch Emmanuel Okala, Pat Ekeji, Ogidi Ibeabuchi, Christian Madu, Stanley Okoronkwo, Chimezie Ngadi, Nnamdi Nwokocha, Emmanuel Osigwe and Alloysius Atuegbu. At Ogbe Stadium, Benin, fans watched wide eyed, the exploits of, Agwo Nnaji, David Adiele, Francis Monidafe, Peter Egharevba, Kadiri Ikhana, Agbonifo, Henry Ogboe, Leotis Boateng and Humphrey Edobor as they turned out for the legendary Bendel Insurance.

The 70s rolled on into the 80s and the players and fans tasted the bitter disappointment of not qualifying for the 1978 World Cup in Argentina, no thanks to an own goal by the usually reliable Godwin Odiye against Tunisia in Lagos, they grasped bronze medal at the 1978 Nations Cup in Ghana, followed by their Nations Cup triumph of 1980 in Lagos, the disappointment again of not qualifying for the 1982 World Cup in Spain, a silver medal at the 1984 Nations Cup in Ivory Coast and yet again the failure to qualify for the World Cup, Mexico in 1986, another silver medal at the 198 Nations Cup in Morocco and another failure, to qualify for the 1990 World Cup in Italy,

So, of assurance, international and club competitions did not fail to give fans their fill of enjoyment. Fans packed the stadia to see the stars. Teams like the all-conquering New Nigerian Bank (with stars like Henry Nwosu, Bright Omokaro, Sunday Eboigbe, Stephen Keshi, Samson Ozogula), Flash Flamingoes of Benin (with talents such as Osaro Obobiafo, Ndubuisi Okosieme), Leventis of Ibadan (with the likes of Bunmi Adigun, Andrew Uwe, Edward Ansah, Bala Ali, Paul Etokebe and Wole Odegbami). Abiola Babes of Abeokuta (with stellar performers like Yisa Shofoluwe, Friday Ekpo, Chris Anigala, Dehinde Akinlotan, Taju Disu), BCC Lions of Gboko (who featured goatee-bearded Toyin Ayinla later to move to Abiola Babes), ACB - African Continental Bank -(with the feared Monday Odiaka who scored goals for fun at National U20 level) and Calabar Rovers (bequeathed with the short and stocky Etim "Maradona" Esin, goal keeping sensation, Etta Egbe and goal-scoring machine Uwem Ekarika).

Throughout this time, the issue of ownership of the clubs and the subject of their financing was still very much a mixed bag. Abiola Babes of Abeokuta was owned by the business mogul, Chief MKO Abiola. Leventis United by tycoon John Mastroudes, while a significant number of the others were funded by the states. A clear policy for all clubs to be fully privately owned by the NFA may well have proved of benefit to develop the football business economy by fully exploiting its popularity.

Will we be asked to sing onerous odes without words?

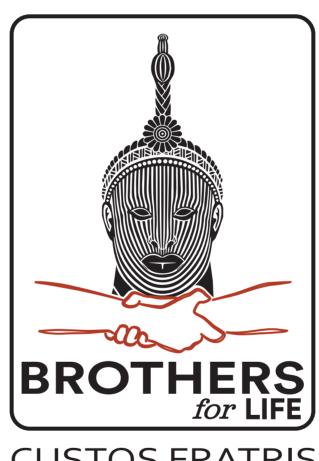
Where lies the shadow of queries, and dreams - what gourds
